Children in foster care (dependent) are the sole recipients of AFFCF awards, which include, but are not limited to: tutoring and educational support, summer camp, extra curricular lessons and classes, athletic registration, bicycles and transportation assistance, educational fees, and post secondary education scholarships.

In addition, AFFCF recently instituted an individualized career exploration and employment program for youth ages 15-21 who are aging out of foster care called "Keys to Success."
